

ST. MARTIN PARISH 2026/2027 52-WEEK RAFFLE

Official Rules

Kentucky Gaming License #: EXE-0000086

1. Sponsor

- The St. Martin Parish 52-Week Raffle is conducted by St. Martin Parish.
- Proceeds from the raffle benefit St. Martin Parish.

2. Eligibility

- Participants must be 18 years of age or older to purchase a raffle ticket.
- Only individuals may purchase tickets.
- Organizations, businesses, groups or other entities may not purchase tickets.
- Purchase of a raffle ticket constitutes acceptance of these official rules.

3. Ticket Price and Availability

- Each raffle ticket is \$52.00.
- A maximum of 1,000 tickets will be sold.
- Each ticket represents one separate and equal chance to win.
- Each ticket will have a unique identifying number.
- Individuals may purchase more than one ticket.
- Each ticket must be purchased separately and provides an equal opportunity to win.
- Tickets may not be reproduced, altered or duplicated.

4. Payment

- Cash and checks payable to St. Martin Parish will be accepted for raffle ticket purchases.
- Electronic payments (such as Venmo, PayPal, Cash App) will not be accepted.
- A ticket is considered valid only after payment has been received by St. Martin Parish.

5. Raffle Period

- The raffle will consist of 52 weekly drawings.
- The first drawing will be held January 3, 2027.
- The final drawing will be held December 26, 2027.
- One winning ticket will be selected each week for 52 weeks.

6. Weekly Prize

- One (1) \$300 cash prize will be awarded for each of the 52 weekly drawings.
- If all 1,000 tickets are not sold, all advertised \$300 prizes will be awarded.
- The weekly prize will remain \$300 regardless of whether all 1,000 available tickets are sold.

7. Drawing Procedure

- Drawings will be held each Sunday following the 10:30 Mass at approximately 11:30 AM.
- Winners will be selected at random from all eligible tickets entered in the raffle at the time of the drawing.
- Every eligible ticket will have an equal opportunity to be selected.
- Chances of winning each week is 1 in 1000.
- Each winning ticket is returned to the drawing pool & will be eligible for all future drawings through 12/26/27.
- The same ticket may win more than once during the 52-week raffle.
- A ticket holder does not need to be present at the drawing to win.

8. Notification of Winners

- St. Martin Parish will notify each winner using the contact information provided with the raffle ticket within 7 days.
- It is the responsibility of the purchaser to provide accurate and legible contact information.
- Winnings may be claimed in person during normal business hours, Tuesday – Thursday 9 AM – 12:00 Noon.
- Winnings must be claimed within 30 days from the date of the drawing.
- Winners may be announced through St. Martin Parish communications, including the parish bulletin, website and/or social media.

9. Claiming a Prize

- The individual whose name appears on the winning ticket will be considered the winner.
- St. Martin Parish requires reasonable identification before releasing a prize.
- St. Martin Parish will require taxpayer information verification such as a W-9 Verification of Identity form or a state issued photo ID (such as a state-issued ID card, Driver's License, Passport etc.) before a prize is released.
- Any prize not claimed within 30 calendar days from the date of the drawing (the time permitted under KY gaming law) will be handled in accordance with Kentucky charitable gaming requirements and will be returned to the St. Martin Parish Gaming account.

10. Taxes

- Raffle winnings may constitute taxable gambling income.
- Winners may or may not receive, depending on the facts and circumstances, a W2-G at the end of calendar year 2027 for the federal and state income tax filing purposes.
- Winners are responsible for any federal, state or local tax obligations resulting from their winnings.
- St. Martin Parish will require taxpayer information verification such as a W-9 Verification of Identity form or a state issued photo ID (such as a state-issued ID card, Driver's License, Passport etc.).
- A winner will be required to provide identification and taxpayer information before a prize is released.

11. Ticket Records

- St. Martin Parish will maintain raffle records as required by Kentucky charitable gaming laws and regulations.
- Ticket information and raffle records will be used for administering the raffle, identifying winners, maintaining required records and complying with applicable legal and tax requirements.

12. Irregular, Lost or Invalid Tickets

- St. Martin Parish reserves the right to reject or void any ticket that is unpaid, illegible, altered, duplicated, counterfeit or otherwise invalid.
- Any dispute regarding the validity of a ticket will be resolved in accordance with applicable Kentucky charitable gaming laws and regulations.

13. Changes or Postponement

- If circumstances require a drawing to be postponed, St. Martin Parish will make reasonable efforts to notify ticket holders of the revised drawing information.
- The raffle will be conducted in accordance with Kentucky charitable gaming laws and regulations.

14. Administration

- The raffle will be administered by St. Martin Parish in accordance with applicable Kentucky charitable gaming requirements.
- Questions concerning the raffle or these Official Rules should be directed to St. Martin Parish.

15. Acceptance of Rules

- By purchasing a ticket, the purchaser acknowledges that he or she has read, understands and agrees to these Official Rules and agrees to be bound by the results of the raffle as conducted in accordance with applicable law.
